To be valid, the proxy form (if this proxy form is signed by your attorney duly authorised in writing, together with a notarially certified copy of the power of attorney or other instrument of authority pursuant to which this Proxy Form is signed) must be delivered to the Hong Kong H Share Registrar of the Company, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong (for holders of H Shares only), not less than 24 hours before the time appointed for holding the Class Meeting of H Shareholders or any adjourned meetings thereof. Completion and return of the proxy form will not affect your rights to attend and vote at the Class Meeting of H Shareholders.
8. Proxies of the holders of the Company's H Shares shall bring along the duly completed and signed proxy form and the proxies' identity cards or passports to attend the Class Meeting of H Shareholders.
